Part of Australia's largest wholesale production nursery group, Alpine Nurseries is recognised nationally for its exceptional plant quality, scale and variety. With sites in Dural, Arcadia and Alstonville NSW, the business spans more than 150 acres and supplies exclusively to trade customers – from landscape architects and designers to councils, developers and government agencies.



The Alstonville site alone is now one of the largest wholesale nurseries in the country, nearly doubling in size in recent years and cementing its role as a key supplier to the national landscape industry.

A culture of excellence, now backed by formal accreditation

Ben Habershon, Operations Manager at Alstonville, has been a driving force behind the site's growth and reputation. With nearly two decades at Alpine and multiple industry awards to his name, Ben was no stranger to NIASA – the national best management practice (BMP) program for production nurseries.

"The NIASA guidelines have long underpinned our operations, but formal accreditation was the next logical step to demonstrate our commitment to quality and environmental responsibility," Ben says.

Recent expansions at Alstonville included purpose-built infrastructure designed to meet NIASA standards. With support from GIA Extension Officer, Barry Naylor, the team moved to formalise its long-standing practices through a structured audit process – providing both external validation and industry credibility.

Empowering staff and sharpening operations

While the NIASA process delivered practical improvements in areas like water use efficiency and crop hygiene, Ben says the biggest gains were cultural.

“Alpine Nurseries has always valued its people and culture. Barry’s training sessions have been incredibly valuable – not just for upskilling, but for building confidence and engagement across our team,” he says.

Pest and disease management training, in particular, has helped the nursery adopt more proactive, preventative strategies – essential in an era of increasing biosecurity pressure.



Strategic insight with lasting impact

The benefits of GIA’s involvement have extended well beyond the accreditation process.

“The value of the extension officer program goes beyond accreditation. It’s a fresh set of eyes on your site – someone who can help identify opportunities for efficiencies, quality gains and long-term improvements you might otherwise miss,” Ben says.

As a strong advocate for the program, Ben encourages other growers to take advantage of the support available. The extension officer program is funded by the nursery levy – so when you tap into the extension officer network, there’s no additional cost to you.
